PET PUPPY PURCHASE AGREEMENT

THIS PUPPY HAS BEEN BRED WITH LOVE AND A SELECTIVE PEDIGREE. NOT ALL PUPPIES WILL BE OF SHOW QUALITY, BUT THEY WILL BECOME CHAMPIONS IN YOUR EYES AND HEARTS.

THIS PUPPY IS TO BE SPAYED (FEMALES AGE 9 MONTHS) AND MALES NEUTERED (AGE 5 MONTHS). THE BREEDER, UPON PROOF OF SPAY/NEUTER, WILL FURNISH NON-BREEDING AKC REGISTRATION PAPERS. IF THE PUPPY IS NOT ALTERED WITHIN THIS AGE LIMIT, ALL GUARANTEES ARE VOID AND NO PAPERS WILL BE GIVEN. HAVING THE PUP ALTERED AT A LATER TIME DOES NOT APPLY.

THE BREEDER GUARANTEES THIS PUP TO BE IN GOOD HEALTH AT THE TIME OF PURCHASE. THIS GUARANTEE IS LIMITED TO THE FOLLOWING:

- * FREE FROM TRANSMISSIBLE DISEASE FOR SEVEN (7) DAYS FROM RECEIVING PUPPY.**
- * ALL SHOTS ARE UP TO DATE AND THE PUPPY HAS BEEN DEWORMED.**
- * GENETIC/HEREDITARY PROBLEMS ARE COVERED FOR ONE (1) YEAR FROM DATE OF BIRTH, AND ONLY IF IT IS A "LIFE-THREATENING" PROBLEM.**
- ***VALIDATION OF THIS GUARANTEE REQUIRES AN EXAMINATION BY A VETERINARIAN, OF YOUR CHOICE, AND AT YOUR EXPENSE, WITHIN TWO (2) DAYS OF DELIVERY DATE.**

THIS IS MANDATORY TO CONFIRM THAT THE PUPPY WAS NOT SICK OR INJURED AT THE TIME OF DELIVERY.

THERE IS NO GUARANTEE AGAINST STRESS RELATED ILLNESSES. THE BREEDER HAS NO CONTROL OVER WHAT THE PUPPY MIGHT ENDURE IN ITS NEW ENVIRONMENT. IN THE EVENT OF DEATH, AN AUTOPSY MUST BE PERFORMED BY A VETERINARIAN TO DETERMINE THE CAUSE OF DEATH. THIS REPORT MUST BE SENT TO THE BREEDER AS SOON AS POSSIBLE. DEPENDING ON THE VETERINARIANS FINDINGS, THE PUPPY MAY BE REPLACED WITH ONE OF LIKE QUALITY, IF AVAILABLE, OR A REFUND OF THE PURCHASE PRICE ONLY.

GUARANTEE IS NOT VALID IF SOLD TO A THIRD PARTY. NO REFUNDS ARE MADE DUE TO FAMILY DISAGREEMENTS, SECOND THOUGHTS OR LAND-LORDS NON-CONSENT.

IF PURCHASER CAN NO LONGER CARE FOR THE PUPPY, THE BREEDER MUST BE NOTIFIED AND GIVEN "FIRST RIGHT OF REFUSAL".

IT IS UNDERSTOOD AND AGREED THAT THE BUYER, BY SIGNING THIS CONTRACT, HAS READ AND AGREES TO THE CONDITIONS SET FORTH IN IT. FURTHERMORE, THIS WRITTEN AGREEMENT CONSTITUTES ALL THE CONDITIONS AND GUARANTEES OF THIS SALE AND NO VERBAL AGREEMENTS BETWEEN PARTIES ARE VALID UNLESS IN WRITING.
